Terms and Conditions

Prerequisites

The short course is open to professionals in health, social sciences including economics, urban planning and others, holding a higher academic degree (minimum of 3 years) or trained professionals with at least one year of professional experience. The medium of instruction is English. Proficiency in the English language is required. Students for whom English is not a first language should hold a level of English equivalent to TOEFL 567 paper / 213 computer / 72 - 94 online, IELTS (5+), DAAD (a, b or c in all categories) or GER-Level B2 or more. Exemption from this requirement may be granted to those who completed higher education in the English language (written proof required with application).

A tuition fee of 5000€ is charged for the 12 weeks course (Core Module) and a tuition fee of 2500€ is charged for a 5 weeks course (for each Advanced Module).

Process of admission

The course is limited to 20 participants. Applications complying with the admission criteria will be accepted without a deadline. Hence the admission process follows a "first-come first-served" process. Completed and signed Application Form is required and can be send by email (signed and scanned copy to mscguh@zmg.uni-freiburg.de) After completion of the registration participants will receive a notification letter and an invoice for the tuition fees.

Withdrawing from application

Withdrawing from application has to be written. Refund requests in form of a postmarked letter (or dated email) prior to 12 calendar days before the start of the course will receive a 50% refund. Non-payment of the received invoice is NOT recognized as a cancellation. All cancellations and requests for refunds MUST be submitted written by the deadlines listed within this policy.

Certificates

Upon completion of the course, participants will receive a "University Certificate" with 16 ECTS for Research Concepts and Methods Module, 10 ECTS for Advanced Modules.

Disclaimer
